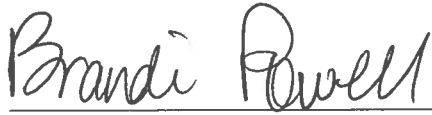
Return for PWA at 6:30 p.m.

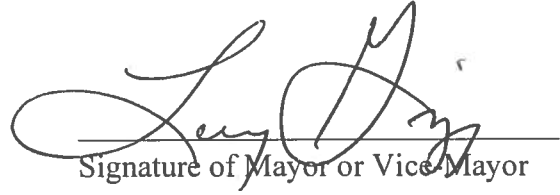
MAYOR'S COMMENTS: Glad our board works better together than our Federal Government.
