TOWN BOARD OF TRUSTEES REGULAR MEETING DECEMBER 30, 2002

The Inola Town Board of Trustees met in regular session Monday, December 30, 2002. Mayor Tommie Grigg called the meeting to order at 7:00 p.m. Members present were Glennie Spurlock, Mike Powers, Erin Oquin, Duane Helling and Tommie Grigg. Also present were Becky Cox and Dale Runyan. Wilma Cargill and Tommy Dyer, Jr. were absent.

A motion to approve the December 9, 2002 meeting minutes as presented was made by Mike Powers 2nd by Duane Helling. Voting yes were Glennie, Mike, Erin, Duane and Tommie.

There were no communications from the floor.

A motion was made by Duane Helling to adopt Resolution R02-11, Notice of Election (for the purpose of electing (3) Town Trustees and (1) Town Clerk. Erin Oquin 2nd the motion. Voting yes were Glennie, Mike, Erin, Duane and Tommie.

Tommie Grigg made a motion to give Gene Cooksey a 5% salary increase 2nd by Erin Oquin. Gene passed the WW Lab C Test. Voting yes were Glennie, Mike, Erin, Duane and Tommie.

Tommie Grigg made another motion to give Dustin Fletcher a 5% increase. Dustin passed the Water C Test. Duane Helling 2nd the motion. Voting yes were Glennie, Mike, Erin, Duane and Tommie.

The item concerning the internet for City Hall was tabled indefinitely. Duane advised we could be connected to the same internet service that the PD currently has.

A motion to amend Animal Control Ordinance sections 4-137 and 4-138 as worded by Town Attorney Tommy Dyer, Jr. was made by Tommie Grigg 2nd by Duane Helling. Voting yes were Glennie, Mike, Erin, Duane and Tommie.

Consideration and adoption of Ordinance #002-01 ^{Correction} was tabled to the next meeting.

Les Wilmott gave the Police Chief's report which covered updates on grants and current projects.

Mike Powers made a motion to accept the only bid turned in on the Fire Dept. F350 Econoline Van, from Glenn Townsend in the amount of \$2,000 which was the minimum bid. Erin Oquin 2nd the motion. Voting yes were Glennie, Mike, Erin, Duane and Tommie.

The November financial report was presented by Becky Cox. A motion was made by Duane Helling to approve the report. Mike Powers 2nd the motion. Voting yes were Glennie, Mike, Erin, Duane and Tommie.

Erin Oquin made a motion at 7:32 to go into PWA 2nd by Duane Helling. Voting yes were Glennie, Mike, Erin, Duane and Tommie.

A motion to approve purchase orders for payment was made by Erin Oquin 2nd by Duane Helling. Voting yes were Glennie, Mike, Erin, Duane and Tommie.

Duane Helling made a motion to adjourn at 7:46 p.m. 2nd by Mike Powers. Voting yes were Glennie, Mike, Erin, Duane and Tommie.
