

**Town of Inola Regular Board of Trustees Meeting  
March 31, 2025**

The Inola Town Board of Trustees assembled at 6:00 p.m. on March 31, 2025, at the Town Hall located at 900 James Ct., Inola, Ok. Mayor Dan Corle called the Town Trustee meeting to order and requested that roll be called by the Town Clerk. Answering roll call were Trent Bynum, Dean Tyler, Mark Redden, Darlene Shear and Dan Corle. Also in attendance was Town Clerk Jayce Springer, Town Treasurer April Padgett, and Town Administrator Scott Devers.

1. Approval of previous Regular meeting minutes as printed.

3. Town Administrator update.
  - The monthly tax revenue in the last six months is about 35-40 thousand dollars monthly.
  - The bank interest since doing sweep accounts has us gaining around \$48,000.
  - The surety bonds are moving to position coverage instead of individual employee coverage along with adding some positions that also handle money.

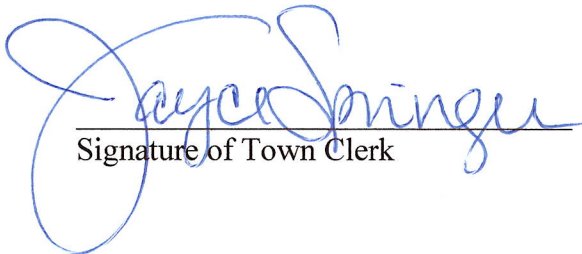
17. Approval of purchase orders.

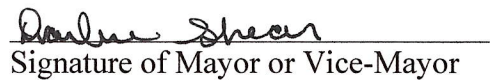
