

TOWN OF INOLA

REGULAR MEETING

MARCH 11, 2002

The Inola Town Board of Trustees met in regular session Monday evening at 7:00 p.m. March 11, 2002 at the town hall meeting room. Mayor Grigg called the meeting to order and answering to roll call were Glennie Spurlock, Mike Powers, Erin Oquin, Duane Helling and Tommie Grigg. Also present were Dale Runyan, Wilma Cargill and Becky Cox.

Duane made a motion to approve the minutes of the previous meeting (2-25-03) as printed 2nd by Mike. Voting yes were Glennie, Mike, Erin, Duane and Tommie. A/A

Fire Chief Billie Padgett was present on behalf of the fire department for approval to pay off the loan on the new building.

Chief Wilmott advised the Board members that Travis Wilks is leaving the department for more money with Rogers County and he would like to advertise in the Claremore and Inola Independent newspapers for a part-time dispatcher.

Duane made a motion to advertise for a part-time dispatcher for the Inola Police Department in the Inola Independent and the Claremore paper 2nd by Mike. Voting yes were Glennie, Mike, Erin, Duane and Tommie. A/A

Les advised the board two of the loans were paid off and needs to barrow \$23,000 to purchase the new police car and equipment. Les obtained seal quotes from both of the local banks.

- 1. 1st Bank 4.9% 60 months
- 2. RCB 4.5% 60 months \$65.00 in fees approximate payment of \$431.50. Filing fee of \$13.74.

Duane made the motion to award the bid to RCB Bank for a lease-purchase on a 2002 Crown Vic for the police department in the amount of \$23,000.00 at the interest rate of 4.5% 2nd by Mike. Voting yes were Glennie, Mike, Erin, Duane and Tommie. A/A

Duane made a motion to go into PWA session at 7:07 p.m. 2nd by Mike. Voting yes were Glennie, Mike, Erin, Duane and Tommie-----back in regular session at 7:09 p.m.

Erin made a motion to approve the claims as presented 2nd by Duane. Voting yes were Glennie, Mike, Erin, Duane and Tommie. A/A

Mike made a motion to adjourn at 7:10 p.m. 2nd by Erin. Voting yes were Glennie, Mike, Erin, Duane and Tommie. A/A
