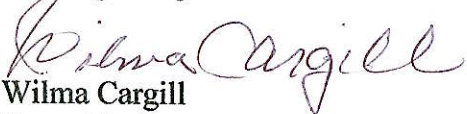
Greg made a motion to approve purchase orders as initialed 2nd by Craig. Voting yes were Craig, Greg and Cheryl. A/A
