Police Chief's report attached.

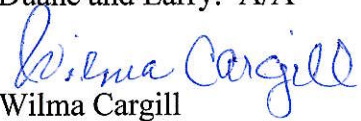

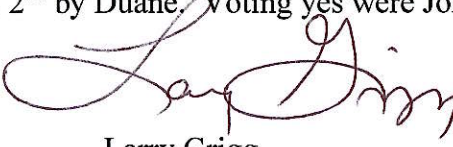
