Regular Meeting

February 25, 2002

The Inola Town Board of Trustees met in regular session Monday evening at 7:00 p.m. February 25, 2002 in the Town Hall Meeting Room. Mayor Grigg called the meeting to order and answering to roll call were Glennie Spurlock, Mike Powers, Duane Helling and Tommie Grigg. Also present were Tommy Dyer Jr, Dale Runyan, Wilma Cargill and Becky Cox. Erin Oquin was absent.

There was no action on amending police policy manual and Tommy Jr advised it has already been approved.

The mayor would like for the community service workers to pick up trash around town. She advised someone tried to get a recycling program started about a year ago, but didn't work out. There is someone that takes a load to Tulsa once a month.

Duane made a motion to approve the financial statement as presented 2nd by Mike. Voting yes were Glennie, Mike, Duane and Tommie. A/A
