Regular Meeting

April 25, 2011

The Inola Town Board of Trustees met in regular session April 25, 2011 Monday evening at 7:00 p.m. in the Inola Town Hall Meeting Room. Mayor Charles called the meeting to order and answering to roll call were John Deboer, Greg Lawrence, Duane Helling, Larry Grigg and Cheryl Charles. Also present were Attorney Tommy Dyer Jr., Clerk Wilma Cargill and Treasurer Glennie Spurlock.

Cheryl made a motion to approve the minutes of 4-11-11 2<sup>nd</sup> by Larry. Voting yes were John, Greg, Duane, Larry and Cheryl. A/A

In new business Lori McClure was present to make a complaint about cars that aren't in working conditions, junk washers, etc that makes the yards unsightly, and nothing is ever done. She believes the citizens should have more pride and interest about the town. She thinks it is a great town to live in and is proud of it. Brad will check into the situation out and has something in the works.

Cheryl made a motion to approve to renew telephone contract between Town of Inola and Telecommunications Service Agreement (TDS Centrex) 2<sup>nd</sup> by Larry. Voting yes were John, Greg, Duane, Larry and Cheryl. A/A

There was some discussion of annexing property at 4200 Road in the area of Subway, however the area is cut-up, areas that were 5 acres have been chopped into smaller areas. They need to find out if property owners will petition in or other ways of annexing can be checked out.

Cheryl made a motion to purchase a Generac Generator for the Inola Town Hall Building from Home Depot in the amount of \$4,487.00 not to exceed the final price of \$6,000.00 with the entire final bill divided equally with Police Department, Fire Department, Public Works Authority, General Fund and Tiawah Volunteer Fire Department 2<sup>nd</sup> by Larry.

Voting yes were John, Greg, Duane, Larry and Cheryl. A/A

There was discussion of a street light located at the Southwest Corner of Inola Casting if there was a need. Chief Craig checked the situation out and did not see a need at this time. No action was made.

There was discussion of Mike Fuller's Museum drive-way being blocked at all hours of the day, they are aware of that being a problem area with Graham's across the street. The attorney advised us to do a resolution to pass at the next meeting. By posting the sign Mr Miller can call the police and they will be able to enforce the ordinance.

Cheryl made a motion to purchase a Do Not Block Driveway sign for the drive-way at the Fuller Museum on North Broadway 2<sup>nd</sup> by Greg. Voting yes were John, Greg, Duane, Larry and Cheryl. A/A

There was more discussion of parking on the North side of Miller's building, it is to his knowledge that he owns the property and should have the right for parking available to his visitors. He was advised to put up signs with a time limit so others won't just park there while going elsewhere, with no action. He just would like the same treatment as other business owners.

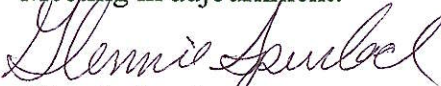
