TOWN BOARD OF TRUSTEES REGULAR MEETING APRIL 8, 2002

The Inola Town Board of Trustees met in regular session Monday, April 8, 2002. A motion to approve the March 25, 2002 meeting minutes as presented was made by Duane Helling 2nd by Erin Oquin. Voting yes were Glennie, Mike, Erin, Duane and Tommie.

A motion was made by Duane Helling to approve the purchase of 2 signs giving directions to the south end of Fleming Park. Mike Powers 2nd the motion. Voting yes were Glennie, Mike, Erin, Duane and Tommie.

Consideration and action to hire a part time police dispatcher was tabled. Les informed the Board that LeAnn Rash was going to start dispatching part time instead of full time. They will need to advertise for a full time and part time dispatcher. Dale Runyan will go ahead and get an advertisement in the Inola and Claremore papers for these 2 positions. This item tabled to the next meeting, April 29th.

A motion was made by Erin Oquin to authorize the Town Treasurer to request sealed bids from each of the local financial institutions for the lease purchase financing of the fire dept. rescue truck 2nd by Duane Helling. (bids to be opened April 29th meeting) Voting yes were Glennie, Mike, Erin, Duane and Tommie.

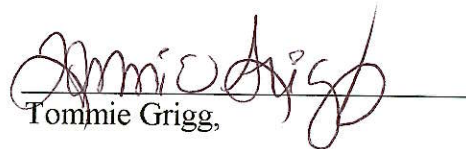
There was no other business and no communications from the floor.
