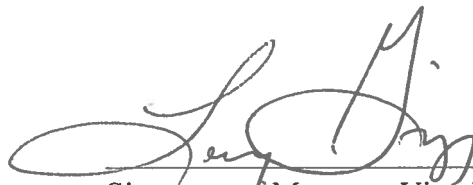
## **MAYOR'S COMMENTS: None**
