REGULAR MEETING

JUNE 25, 2001

The Inola Town Board of Trustees met in regular session Monday evening at 7:00 p.m. June 25, 2001 in the Town Hall Meeting Room. Mayor Grigg called the meeting to order and answering to roll call were Glennie Spurlock, Mike Powers, Duane Helling and Tommie Grigg. Also present were Town Attorney Tommy Dyer Jr., Becky Cox and Wilma Cargill. Erin Oquin was absent.

Duane made a motion to approve the minutes of 6-11-01 as printed 2nd by Mike. Voting yes were Glennie, Mike, Duane and Tommie. A/A
