Mayor asked everyone to leave the room.


Greg Lawrence came in at this time.

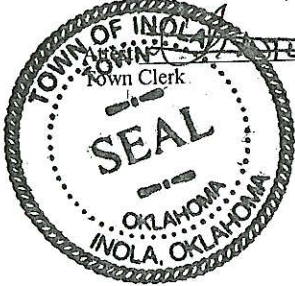
