Mayor Charles called the meeting to order and answering to roll call were Shane McNichol, Glennie Spurlock and Cheryl Charles. Also present were Clerk Wilma Cargill and Treasurer Amy Smith. Absent were Shane Atwell and Larry Grigg.

Brad was present to inform the board he found an officer willing to work the hours and the rate of pay the town pays, also he is certified. May need to send him for week of training.

Board member Larry Grigg recommended him to Brad.

Cheryl made a motion to hire Clay Troutman as a full time patrol officer at the rate of \$775.32 per pay period beginning February 19, 2007 2nd by Glennie. Voting yes were Shane, Glennie and Cheryl. A/A
