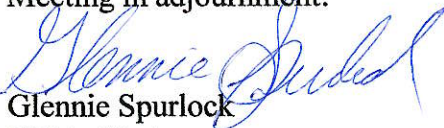
Cheryl made a motion to approve the minutes as printed 2nd by Larry. Voting yes were John, Duane, Larry and Cheryl. A/A
